A BILL

To amend the Sugar Act of 1948 to terminate the quota for South Africa.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That Congress hereby finds that it is not in the interest
4 of the United States to provide official support in any form
5 to a country whose racial policies are anathema to the
6 conscience of the world and have been so denominated by
7 the United Nations, and that the Republic of South Africa,
8 having adopted such policies, should therefore not enjoy

1 the privilege and benefit of a quota under the Sugar Act
2 of 1948.

3 SEC. 2. Section 202 (c) (3) (B) of the Sugar Act of
4 1948 is amended by deleting

"South Africa----- 1.06".

5 SEC. 3. A quantity of sugar equal to the amount of
6 the quota withdrawn from South Africa shall be prorated
7 in the same manner as deficits are prorated under section
8 204 of this Act.
