## MEMORANDUM

 SUBJ: House Disinvestment Meeting with Rep. Rose

For your information, we have attached copies of correspondence relevant to our Thursday meeting with Charlie Rose, who is Chairman of the Subcommittee on Office Systems. As these materials reflect, responses from companies on the House Administration's Equipment approved list have been pending since June 15,1985. We have made formal requests for preliminary findings as early as August of this year, and repeated inquiries have been made by staff to the Subcommittee on Office Sytems beginning in Sepetember to secure a report on the bases of Rep. Rose's communication. To date, the response to efforts made on behalf of the CBC leave us to conclude there is reluctance on the part of the Committee to proceed with this inquiry. We have therefore insisted on a meeting with Rep. Rose, which after some difficulty has been scheduled for Thursday; Using a December 10th at 5:30 p.m. in his office at RHOB-2230.

I would like to commend Ron Dellums and his staff for their leadership on this issue.We ask that you consider for the purposes of discussion with Chairman Rose the following options:

- A) An immediate release of the findings of the Subcommittee on Office Systems based on the request for businesses and subsidiaries doing business in South Africa
- B) An official ruling on legal ramifications of severance of contracts for purchase and service of equipment through Hourse Office Supply and Systems

- C) A proposal for hearings on the question of disinvestment by the House of Representatives by either the full Committee on House Administration or the Subcommittee on Office Systems
- D) As an interim measure, the approval of the addition to the listing of companies in the 1986 Equipment Book -- a notation identifying that company as doing business in South Africa, the listing of alternative companies (particularly minority owned businesses) as optional selections, and the inclusion of an additional line to new contracts which indicate that the Member enterning this contract is aware that the specified company is engaged in business in South Africa.
