On Wednesday, March 26, 1986, I will conduct an indepth briefing to examine various aspects of South Africa's continuing crisis. The briefing will be entitled: South Africa and The Congress—An Update.

The briefing will be held at the George Fallon Federal Building, 31 Hopkins Plaza, level G, Room 26-B, in Baltimore, Maryland. It will begin at 9:30 a.m. and will conclude at 12:30 p.m.

South Africa's current state of affairs will be analyzed by Members of Congress representing the House Foreign Affairs Committee and the Congressional Black Caucus. Among those Members participating in the briefing are: Rep. Howard Wolpe, Chairman of the Subcommittee on Africa; Rep. Michael D. Barnes, Chairman of the Subcommittee on the Western Hemisphere; Rep. George W. Crockett, Member of the Subcommittee on Africa; and Rep. Walter Fauntroy, Member of the Congressional Black Caucus.

Over the past year, we have watched the horrors of apartheid, a cruel system of life enforced by whips, police dogs, torture, and death. It is for your benefit to join us on March 26 and learn about U.S. policy in Southern Africa, action taken by the U.S. Congress, and to discuss other aspects that may promote a peaceful solution.

It is extremely important that you be with us on Wednesday, March 26, 9:30 a.m., at the George Fallon Federal Building, 31 Hopkins Plaza in Baltimore.
