
Enclosed please find the final agenda and all related correspondence concerning the upcoming Congressional Briefing on South Africa.

MITCHELL ANNOUNCES CONGRESSIONAL BRIEFING ON SOUTH AFRICA

On Wednesday, March 26, 1986, Congressman Parren J. Mitchell (D-7th-MD) will conduct an indepth congressional briefing to examine various aspects of the plight of Blacks in South Africa.

The briefing will be held at the George Fallon Federal Building, 31 Hopkins Plaza, level G, Room 26-B, in Baltimore, Maryland. It will begin at 9:30 a.m. and will conclude at 12:30 p.m.

South Africa's current state of affairs will be analyzed by Members of Congress representing the House Foreign Affairs Committee and the Congressional Black Caucus. Among those Members participating in the briefing are: Representative Howard Wolpe, Chairman of the Subcommittee on the Western Hemisphere; Representative George W. Crockett, Member of the Subcommittee on Africa; and Representative Walter Fauntroy, Member of the Congressional Black Caucus.

"We continue to watch the horrors of apartheid," Mitchell said, "the cruel system of life imposed on Black South Africans through death, whips, police doys, and torture."

The public is invited to participate in this congressional briefing to learn about changes proposed in U.S. Policy in South Africa; actions which may be taken by the U.S. Congress and to discuss strategies that may promote a solution to the South African crisis.

This briefing is open to the public on Wednesday, March 26, 1986, 9:30 a.m. at the George H. Fallon Building, Room 26-B, 31 Hopkins Plaza, Baltimore, Maryland.
