

Enclosed you will find a copy of the report entitled "The Oil Conspiracy" the subject of which is the role of Mobil Corporation in breaking United Nations Sanctions Regulations pertaining to Rhodesia.

The information contained in this report was publically released at a press conference in Washington D.C. on June 21st, 1976. To date, both the United States Treasury Department and Mobil Corporation have indicated that they are investigating the matter. On July 2nd, a joint presentation of this material was made by the Center for Social Action and the U.S. Anti-Apartheid Movement before the United Nations Sanctions Committee. We are informed that this committee is awaiting the U.S. Treasury Department's report before taking further action.

The United States voted for Security Council Resolution Number 253 thereby indicating that they supported economic sanctions being brought to bear on the Smith regime in Rhodesia as a means to the achievement of majority rule in that country. President Johnston then promulgated two executive orders incorporating the essential clauses of the sanctions regulations into the U.S. legal statutes.

The American Mobil Corporation has been involved in the supply to Rhodesia of oil - a crucial product for the maintenance of power by the Smith regime.

The Center for Social Action, in its concern for human justice and liberation, regards this matter of utmost importance and as a matter in need of urgent attention. If U.S. laws have been broken, then Mobil Corporation should be prosecuted. If the information in this report does not constitute a violation of U.S. law, then there are loopholes in our laws which defeat the purpose of the spirit in which we agreed to the implementation of international economic sanctions against Rhodesia.


