**Atlantic Tunas Convention:** House agreed to Senate amendments to House amendments to S. 2549, to authorize appropriations for fiscal years 1981, 1982, and 1983 to carry out the Atlantic Tunas Convention Act of 1975—clearing the measure for the President.

**Small Vessels:** House disagreed to Senate amendment to H.R. 5164, to amend certain inspection and manning laws applicable to small vessels carrying passengers or freight for hire; and asked a conference. Appointed as conferees: Representatives Ashley, Murphy of New York, Biaggi, Breaux, Oberstar, Hughes, McCloskey, Snyder, and Livingston.

**Housing and Community Development:** By a yeand-nay vote of 291 yeas to 43 nays, Roll No. 480, the House passed H.R. 7262, to amend and extend certain Federal laws relating to housing, community and neighborhood development and preservation and related programs.

By a yeand-nay vote of 313 yeas to 3 nays with 2 voting "present", Roll No. 478, the House agreed to resolve itself into the Committee of the Whole.

Agreed To:

An amendment that provides for a legislative veto of any rule or regulation promulgated by the Secretary of HUD;

Committee amendments to title V;

An amendment that strikes the retroactive application of a prohibition against developers of low-income rental housing in rural areas from changing the term of their contracts without USDA approval (agreed to by a recorded vote of 230 yeas to 108 noes with 1 voting "present", Roll No. 479); and

An amendment that provides that Social Security benefit increases effective after May 1980 not be considered as income for purposes of determining eligibility for federal housing assistance.

Subsequently, this passage was vacated and S. 2719, a similar Senate-passed bill, was passed in lieu after

being amended to contain the language of the House bill as passed.

The Clerk was authorized to correct section numbers, punctuation, cross references, and to make such other technical and conforming changes as may be necessary in the engrossment of the House amendment to S. 2719.

**Historic Sites and Buildings:** House agreed to H. Con. Res. 410, directing the Secretary of the Senate to make corrections in the enrollment of S. 2680, to improve the administration of the Historic Sites, Buildings, and Antiquities Act of 1935 (49 Stat. 666).

**Mental Health:** By a yeand-nay vote of 277 yeas to 15 nays, Roll No. 483, the House passed H.R. 7299, to revise and improve the Federal programs of assistance for the provision of mental health services.

Rejected a motion to recommit the bill to the Committee on Interstate and Foreign Commerce with instructions to report the bill back to the House with an amendment that sought to extend the Community Health Services Program for two years with a ten per cent increase in the funding of the second year (rejected by a recorded vote of 75 yeas to 223 noes, Roll No. 482).

Agreed to committee amendments of a technical, clarifying, and conforming nature.

Rejected an amendment in the nature of a substitute that sought to extend the Community Mental Health Services Program for two years with a ten per cent increase in the funding of the second year.

Subsequently, this passage was vacated and S. 1177, a similar Senate-passed bill, was passed in lieu after being amended to contain the language of the House bill as passed. Agreed to amend the title of the Senate bill.

H. Res. 751, the rule under which the bill was considered, was agreed to earlier by a voice vote.

**U.S. Forest Service:** House agreed to H. Con. Res. 393, extending to the Forest Service, United States Department of Agriculture, the appreciation of the Congress on the seventy-fifth anniversary of the founding of the agency.

**Camp Fire Girls Memorial:** House passed S. J. Res. 83, to authorize the Camp Fire Girls of Cundys Harbor, Maine, to erect a memorial in the District of Columbia—clearing the measure for the President.
