Congressmen Harold Ford (D-TN) and George Crockett (D-MI) will co-chair the Aging Braintrust Workshop. The braintrust will concern itself with:

- Reagan Administration budget policies regarding the Black elderly, with special emphasis on Social Security proposals;
- December 1981 White House Conference on Aging;
- reauthorization of the Older Americans Act; and
- Black aging advocacy in the 1980s.

# Arts and Humanities

Congresswoman Shirley A. Chisholm (D-N.Y.) will chair the Arts and Humanities Braintrust Workshop. The braintrust will concern itself with:

- the Reagan Administration's proposed 50% cut in funding for the National Endowment for the Arts and Humanities; and the
- assessment and evaluation of recommendations made by the Reagan Administration task force organized to study the formation of a public corporation as an alternate source to the National Endowment for the Arts and Humanities.

### Civil Rights

Congressman Harold Washington (D-Ill.) will chair the Civil Rights Braintrust Workshop. The braintrust will concern itself with:

- current laws and programs with a view toward future directions; and
- examining voting rights and employment discrimination issues.

#### Communications

Congressman William L. Clay (D-Missouri) and Congresswoman Cardiss Collins (D-Ill.) will co-chair the Communications Braintrust Workshop. The braintrust will concern itself with:

- the focus on poor coverage by major news industries of minority activities and leadership;
- identifying root causes of this problem and developing a viable solution; and
- examining lack of Black ownership and employment in the cable television industry.

### Corporate Affairs

Congressman Julian C. Dixon (D-Calif.) will chair the Corporate Affairs Braintrust Workshop. The braintrust will concern itself with:
